- (1) No supply of alcohol may be made under the premises licence –
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- (3) The admission of children to the exhibition of any film shall be restricted according to the classification of the film by the film classification body designated by section 4 of the Video Recordings Act 1984.

Annex 3 – Conditions attached after a hearing by the licensing authority

- a) Microphones with amplifiers permitted up to 23:00 indoors all days and up to 21:00 outdoors.
- b) Windows and doors to be kept closed, including kitchen and food preparation area to be kept closed between 23:00 and 01:30.

Supply of alcohol:

- c) Up to 12 event days per annum at the Licensee's discretion Friday's and Saturdays to midnight, to include drinking up time.
- d) Consumption of alcohol after 23:00 indoors only.

Hours premises are open to public:

- e) 01:30 closing on non-standard hours days, to include 30 min's drinking up time, allowing sale of late night refreshment.
- f) Notices shall be displayed in the car park and at exit doors to encourage customers to leave the premises quietly. All staff asked to reinforce this message.
